2010 OCA Nationals Update


The 2010 Nationals team is still working our 2010 event although you may not see it. Here are the latest updates that we have:

<u>Don Jack</u> has been actively working the show field lay-out. He also has helped us to determine that we will need to limit show car registration to 450. A point of interest is that Don did a study of all the National events for the past nine years and determined that the *average* event had 453 show cars. We will need someone to help Don with a scale computerized lay-out in order to determine a safe traffic pattern as well as helping to show class placement. We can also use this information to help with our next annual show in Sturbridge.

<u>Everett Horton will also need this above information to support his background work for the swap meet</u>. Everett has been in touch with community officials and others to work through the logistics and legalities of holding a swap meet in the Sturbridge area. <u>Earl Bancroft</u> is Everett's right hand man and has offered several concrete suggestions to support this. Since Earl lives 15 minutes away from Sturbridge, this will be a great help to Everett.

<u>Ted Loranz</u> has a sample Access data base from OCA to work with for our event which will be primarily used for registration. We had several different data bases offered to us but Ted is more comfortable with Access and will probably use that. He will need several pieces of information to feed this database including the events calendar from Ed Palmieri, the logo from John Lenihan, and pricing which will be determined later.

<u>Ed Palmieri</u> has worked on several event activity schedules and is narrowing them down to something that we can begin to advertise. These include but are not limited to, a trip to Boston, one or two trips to a casino, a trip to Mystic Seaport, Women's luncheon and trip to Mystic Village and the aquarium, and others still being looked at. <u>Steve Minore</u> has joined Ed to help with these activities and especially to help coordinate any drag racing event activity at Lebanon Valley. We also need to determine bus transportation to support any ac-



tivity and are open to suggestions. We hope to have a tentative event schedule to present at the 2008 Nationals in Detroit this year.

John Lenihan has been using his creative talents to develop several logos to represent us in 2010. We have narrowed the selection down to three but have not yet determined the final choice. Because of the great choices, we may use one main logo for advertising and show apparel and a smaller logo for lapel pins and a pocket patch for shirt fronts. Stay tuned.

Bill Black and I (remember us?), will be working on a presentation for the 2008 Nationals for the OCA Board. We are entertaining a 70's theme for 2010 to go along with the 40th anniversary of OCA and are open to suggestions. Bill has also offered to make another trip to Sturbridge to talk with the Chamber of Commerce to establish contacts. We will both be at the GMO show to answer any questions and hopefully recruit some GMO members to help us in 2010. We also plan to start talks and make arrangements with Sturbridge area overflow hotels. *We are still looking for a chair person to support the awards banquet* and we need as many volunteers as possible to help the judging, registration, show field parking, and sight seeing committees.

Directions From I-91 North or South :

Take Exit 47E and follow Hazard Ave. (SR-190) East for almost 7 miles. You will come to a traffic light just beyond the new Fire House (on your right), Sokol Rd.

At that light take a left onto Sokol Rd. and follow it for about 1 mile to stop sign.

Go straight through onto Avery Rd. and proceed to the end (about ¹/₄ mile) at the stop sign.

Take a left onto RT83 (also know as Springfield Rd.)

My house is # 465 about 1 ¹/₄ miles up on your left. (Grey Cape with Blue Shutters). There is a large yellow sign with a picture of a stop sign and an arrow pointing straight ahead...my driveway is directly across the street from that sign. If you get to the traffic light you went too far.
